- 2. We have sent out the first two quarters of the Words & Music

has been recommending band grading for years. At the 2009 AGM the membership asked the EC to start working on a grading system for soloists. Bob Mason and the Music Board were instrumental in starting that process. However, it was felt until the process was fully developed that we still allow self-grading. For the last couple of years we have received a few requests for solo upgrades. We are now at the point in this process where we feel confident that the grading committee can now implement this grading process. With that thought in mind PLEASE NOTE that the Executive Committee will be fully supporting a Bylaws proposal that will enable the Music Board Grading system to be implemented and will no longer allow selfgrading. It's coming up folks so be aware.

- 4. The current Bylaws changes have been made and are now posted. In addition to the Bylaws, the Executive Committee had asked Andy Trimble if he would edit the current bylaws for any grammatical errors as well as changing the voice in the Bylaws from passive to active voice. We will be sending out a copy of the consolidated Bylaws to the membership prior to the AGM so that those Bylaws can be reviewed which hopefully will shorten the discussion and voting time at the AGM.
- 5. As of this writing the minutes from the AGM are 95% completed and will be posted in the next week or so.
- 6. The creation of a Publications Committee has enabled us to revise the old WUSPBA Rep Manual which is used by the WUSPBA Rep, Games Sponsors and contest organizers. This manual is a one stop shop for anyone wanting to learn how to setup and run a WUSPBA Sanctioned Contest. In addition, the Publications Committee will be handling all publications coming from the Executive Committee. I want to thank Erin Gunn for all of the many hours and hard work she and her

committee have spent on this project. The manual is in final review and should hopefully be posted in the next week or so.

- Kevin Conquest is chairing the Drum Major Committee and has met on a couple of conference calls. I will let Kevin talk about some of the exciting ideas that is coming out of there committee.
- 8. Andy Trimble who is Chair of the IT Committee has been working hard on a centralized database C-TAMS (Central Administrative Management System) for the Executive Committee, Music Board, Solo and Band Members and Games Sponsors. This is a project that I have been personally wanted to see come to fruition for quite a while. Soloists will be able to register, pay their fees and receive there WUSPBA solo card and kilt number immediately alleviating the need for emailing registration cards and kilt numbers. Bands will be able to submit roster changes and receive their rosters in a very efficient manner. Games Sponsors can register and sanction their games online also in a very streamlined manner. This database will be extremely helpful in that all contest results, adjudication information, grading information, and critical information that the Music Board requires to make Adjudication and Grading decisions will now be at their fingertips. Again my grateful thanks to Kylene Tanner, Erin Gunn, Todd Brown, and Andy Trimble who will be making the magic happen.
- 9. With the advent of a new centralized database

system we are updating our current website. Work is underway on the design for the new website. We are hopeful that this will greatly enhance our ability to communicate with you,

our members. We have been using the WUSPBA News to get out timely updates to the membership. Hopefully you have signed up for that. Let us know if you haven't received those updates. We have an EMAIL Blast that goes out to Pipe Majors, and Drum Sgts. We have used this when we have wanted to get information out to the



bands and I feel has been working fairly well. However, if you or your band has not received an email blast from me in the last three months we need to sign you up. This is an incredibly important communication tool that we have. I want to thank Andrew Lenz and Dane Chambers who have been absolutely incredible with their support since the start of this administration in posting and updating the current website. Again, I want to thank Andy Trimble for helping us set up the PM/DS Email Blast.

- 10. With the new Music Board in place we have formed four Music Board Committees: an Adjudication Committee, Grading Committee, Education Committee, and Contest Committee. These committees are hard at work on various projects dealing with the different musical aspects of the association. My many thanks to the Music Board and Andy Trimble for their hard work.
- 11. Stuart Baker is in charge of the AGM Committee and he has been working hard on this project. Inasmuch as we are celebrating the 50<sup>th</sup> Anniversary of WUSPBA Stuart has asked Michael LeBoeuf to help in planning some of the fun activities we will be experiencing this year at the AGM. The AGM will be held on October 26,

2013 in Las Vegas. Stay Tuned to further details.

12. The Music Board is working on guidelines regarding adjudication appointments to the judging panel. This will be a comprehensive manual that will assist in detailing just what is expected in the adjudication appointment process from beginning to end. In addition it will outline the process for recertification of adjudicators (Don't panic judges, at this point it will not involve taking exams) as well as a promotional process for moving judges from the B panel to the A.

13. Logo Contest: As most of you know, we have been holding a logo contest which has now ended. We will be posting the entries on the website. You will have the opportunity to pick the top six. Then we will have a second vote where you can pick the top 3. The Executive Committee has the rights to use the logo however we will, or not use it depending on the need. The top 3 winners will receive cash prizes. The membership should email me at Jeffrey.mann@hsc.utah.edu.

- 14. In addition to the Logo Contest we have a tune writing (composition contest) underway. I wanted to clear up a misconception and will post this on the WUSPBA website. We have had a few composers write in with questions regarding the copy rights to the tunes. Just to be clear, a new disclosure has been written up and basically states that the composer has and keeps full rights to their composition but allows WUSPBA a license to do with it as it will. The top three winning tunes will receive cash prizes and in addition we are working on a tune collection project of music for the WUSPBA 50<sup>th</sup> anniversary. This collection will then be published. We are hoping that this WUSPBA 50<sup>th</sup> Anniversary Golden Jubilee Tune Collection will be complete by the AGM on October 26<sup>th</sup>. Lorne Cousin is currently Chair of this project under the auspices of the Music Board.
- 15. An Audit Committee has been created and is in the initial stages of an audit of our books. We

- should see the results of this audit within the next couple of months.
- 16. Branch monies have been sent out to the different branches. My great thanks to David Mackenzie who has been very supportive of both the audit and the financial affairs of WUSPBA.
- 17. Band and Solo registrations are well underway along with games sanctioning. Erin Gunn is our new solo registrar and has met her learning curve dealing with solo registration very well. Again, with the advent of a new centralized database system we are hoping to streamline even more our current processes dealing with sanctioning and registration.
- 18. The newly created President's Council has been hard at work. Susan Thornton, Chair of the committee works hard along with John Biggar, Stu Baker, Andrew Morrill, Chris Hossack and Scott MacDonald. Their job is to take issues that the Executive Committee feel might require additional thought of people much wiser than I and have them discuss at their level and then send their recommendations back to the Executive Committee. We have already called upon them on a couple of issues and their help has been tremendous. In addition to their council they have been tasked to organize a "Presidents Circle of Honor Brunch". This will be to honor the Life Members and Past Presidents of WUSPBA. More details will be forthcoming.
- 19. The Northern Branch has been re-organized and I am pleased to welcome Lisa Graves as the new President of the Northern Branch. Amber Bartholomeusz is the Vice-President along with Richard Charette as Executive Secretary and Donna Smith as Treasurer. They held their first Branch Executive Committee meeting on February 9<sup>th</sup> and they have some exciting plans coming forward. We extend to them a very warm welcome and wish them the best of luck!
- 20. The Southern Branch will be holding their elections during the Costa Mesa Games on

Saturday right after Massed Bands.

- 21. Marshall German was selected to represent WUSPBA at the Metro Cup. Congratulations Marshall on being selected.
- 22. 2012 entire Band and Solo results are now posted. Trophies have been mailed out to the aggregate winners. Congratulations to the bands and soloists for all of their hard work.
- 23. I had the awesome opportunity to attend Winter Storm and was greatly impressed with the ability to live stream the competitions. I have tasked the IT committee to look into the possibility of doing the same for possibly the Costa Mesa or Pleasanton Games. If any of you have a working interest or knowledge of how this can be done on a limited budget, I would certainly like to hear from you. Jeffrey.mann@hsc.utah.edu
- 24. The Executive Committee has appointed Darrell Calvillo as Historian. He has been tasked at creating a history for the AGM as well as working on capturing the history of the bands in WUSPBA. This is an exciting project as we will have video biographies on a lot of the history of WUSPBA. If you know of anyone that might be interested, in serving on this committee please let us know.
- 25. It is with deep regret that I announce that David Mackenzie is stepping down as Treasurer of WUSPBA because of family health reasons. I will miss David as he was a good friend and mentor of mine. We have appointed Scotty Dean to replace David as Treasurer for the remainder of his term. Scotty is not new to the position as he served as Treasurer for several years.
- 26. I am very happy to announce the formation of the "Music Development of the Art and Performance Committee" or "MDAP". This committee will serve as a subcommittee of the Music Board and will receive direct oversight from Andy Trimble, Chair of the Music Board. This Committee's focus will be developing the art and performance of Pipers,

Drummers, and Drum Sergeants through non-competitive projects and structured learning. Since we are doing well on the competitive side of our mission, this committee will work on the non-competitive side and will have oversight over some of the branch educational activities. As the 2013 season gets up to steam, I'd ask you to keep something in mind as you visit various competition venues: there is a lot of work going on behind the scenes. It's easy to be critical when you drive up in your car, park, walk onto the field and find your event is running late, some platform got unexpectedly moved, results aren't posted quick enough for your liking, etc.

There are months of preparation that go into hosting an event. Plus a fair amount of risk; there is no guarantee that an event will break even, but judges and venues fees are set in stone. Solo fees often don't cover the cost of a judge and while the argument could be made that soloists are a big draw for general

ticket sales, do you see large crowds of the general public watching soloists compete? Nope. Even a large venue like Pleasanton will still only find a smattering of spectators, and many are family and friends of the individual competing! Pipe bands are a bigger draw, but even then there is no guarantee that the games will be a success. It might surprise you but there are years that even a long-standing successful event like Pleasanton Games will go into the red.

Occasionally, I'll hear people complaining that "my family and friends should get in for free" and "why should my wife have t buy a ticket?" Perhaps you'll



start to understand why such arguments, if won, could spell the end of highland games.

Aside from the financial demands, there are exhaustive time demands. You might start to figure out just how easy it is to overlook some planning detail here or there that seems like such a hassle to you at the time.

Some number of years ago, I remember one games that I attended where I felt it was more disorganized than I preferred. Did I complain? Maybe a little. But more importantly, I approached the games organizer and volunteered to run the solo competition. Being that I knew exactly what I wanted as a soloist myself, I could

> run the competition to the liking of those participating and it went very well for a number of years before a rainy weekend impacted the "gate" enough to kill that games.

The administration of games and your pipe band association is composed of people just like you. If everyone were to sit on their hands and not volunteer, everything we've come to enjoy in the piping and

drumming scene will cease to exist. If you aren't quite ready to volunteer yourself – and give it some serious thought – at least be thankful and patient with those who have.

# Band Registrar's Report

Greetings from the deep freeze. After surviving one of the coldest Januaries on record, I am nearly ready to ship myself to my brother's home in El Paso. Weather aside, January means band registration season. I spend nearly all of my "free" time working on registration and rosters. Although the online registration system has reduced the sheer volume of work, it is still a challenge.

During this winter, I have had the opportunity to once again review my

I have taken a personal challenge to review the best practices and overall structure of the other

For example, I get hounded over and over about the need for a school rule. After all, they tell me, "Everyone Else Does It!" Nonsense. Only two of the 11 associations have such a rule, and when you look at the

combination of the school rule with the registered instructor and dual musician policies, as well as the limitation on how many bands an instructor may register with, plus the requirements of the school rule, our liberal policy of allowing all juvenile grade 5 members to play in any other band with no penalty is actually much more open.

Another argument I get is that "everyone else" allows grade 5 to play a timed medley. Actually, only one association does. Remember that when you are approaching me with the type of

> argument that we have to do something because everyone else does it, I have all of the rules at a glance. Ask away, but don't expect me to believe that "everyone else" has an advantage that you don't. It is just not true. There is not an association in North America with looser rules.

Now on to other matters. I am not planning to run again for Band Registrar. At the end of this term, I will have served in this position for six years. It is high time for someone else to pick up the torch. I am only partially kidding when I say that if you want to demand rule changes that take work for anyone in the Executive Committee, you put your time on the line and serve. On the Executive Committee we are working on a better association, and nitpicky time wasters are not helpful.

The petty annoyances aside, I am grateful that so many of you are sincere and are simply in this hobby for the art of it. You are the ones that make my life easier. I can really count on maybe two hands the number of people (organizations) that are constantly causing me grief. The vast

# Drum Major Committee's Report

1. The Queen Mary games kicked off the 2013 season and the drum major competition was a huge success! We saw 20 drum majors competing, 10 of which were in the juvenile

grade. This demonstrates a continual increase of participation at WUSPBA events; moreover, this was the largest turnout of drum majors in the history of the Queen Mary games. Additionally, we held the invitational "classic" competition where 4



adult drum majors are selected to lead the Los Angeles Scots Grade 1 band through a course. This local option event is judged jointly between the band and adjudicator, selecting the best leader on the march.

2. Dave Melton has started work on

instructional material for bands regarding mace signals and commands. The goal is to produce an informative reference that will improve the understanding and communication between bands and drum majors in massed bands. We intend to supplement printed reference with YouTube videos. This will all be provided free of charge to our membership.

3. I have sent a formal introductory letter on behalf of WUSPBA to WO1 Ben Roberts, the Senior Drum Major of the British Army in hopes of opening communication and obtaining updated drill manuals to aid the creation of our instructional materials. I am also awaiting contact info for the Senior Drum Major at the Army School of Bagpipe Music and Highland Drumming in Edinburgh.

4. David Cubberly has received a list of all registered WUSPBA drum majors dating back to the 1990s. We note the number of expired registrations; David will be contacting these competitors to find out why they have lost interest in WUSPBA. He is also going to find out how we can better serve our drum major competitors to retain current and future registrations.

5. Jason Paguio has kicked off 2013 crosspromotion between World Drum Major Association and WUSPBA by holding a Scottish style contest using WUSPBA rules at the Glendora High School solo drum major competition on March 2nd. The high school marching band circuit attracts at least 40-50 competitors to each of their events. This will be an amazing opportunity to expose new drum majors to the Scottish style of competition. Both Jason and I will be on hand to promote the benefits of joining WUSPBA and talk about what pipe bands do at Highland Games.

6. Ken Misch has brought up an excellent point that our main source of new competitors (kids from the high school) find our events hard to get into with the expense. He is certainly right! A uniform is not cheap and some of these kids try to do this without joining a pipe band. Add the solo membership to WUSPBA and individual contest registrations to this list and it becomes daunting for teenagers. We are all looking at ways to subsidise expenses for juvenile drum majors. We must also strongly encourage bands to welcome drum majors into their ranks!

7. I am helping Erin Gunn track down the WUSPBA adjudicators who have not paid their dues to find out if they are still interested in being on the panel and participating.

Lastly, our committee intends to finalise the rules and requirements for a novice grade of adult drum majors in time to do a voluntary pilot by Costa Mesa.

Please feel welcome to contact me or any of our committee if you have questions or ideas. This is a symbiotic relationship at stake - drum majors need bands and every band ought to have a skilled drum major to help and add to every performance.


The branch has also awarded two scholarships to a piping and drumming school of their choice to Cody Steck for piping and Tiffani W. Brush for


