A New Branch!

One of the big things to happen was the creation of a new branch. The Desert Branch was formed and will represent all of Arizona and the Las Vegas area. Kevin Conquest is the acting president and has his leadership team in place and running smoothly.

The WUSPBA Board felt that this move was needed to help us better represent the bands in Arizona and Las Vegas area. An R2 System Update

I would like to give members some updates on the R2 system. There are more and more games taking advantage of this system, which will allow the soloists and

bands to have a more consistent experience.

A More Predictable Experience

We acknowledge there are still issues to overcome, and are working with the vendor to overcome these issues. Much of the work being done is in areas the average user doesn't see. These include scheduling and processes that will help make the games organizers' tasks easier, and hopefully deliver a more predictable experience for band and soloists.

Stable, Reusable Infrastructure

The biggest advantage is that as games change organizers, volunteers and

committees, the infrastructure and systems will be in place, stable and reusable year after year.

Feel Free to Suggest an Alternative System

We have had some very loud and vocal members ask us to get rid of the R2 system or replace it. If anyone has a viable alternative system to suggest, we would gladly investigate other options.

But as we have to keep reminding ourselves as well as others, this system is much more than a simple membership registration system. It also does event management, member communications, and in the future, hopefully, results-tracing, and liveresult input.

Happy New Year, everyone!

Elsewhere in this newsletter Andrew Morrill has discussed what went on at the ANAPBA Summit meeting held in Kansas

City. Both Lise Nelson and I attended the Music Board sessions of the Summit, and we both agreed it was quite valuable. But in this article I'd like to focus on the WUSPBA Music Board and its current activities.

2016 was a year in which the Music Board took the time to focus on just a few

priorities rather than try to tackle too many issues at once. Here's what we accomplished, where we're heading and why I'm feeling confident that we are on track to deliver value to WUSPBA and its members.

Adjudicator Development

The Adjudicator Development Program had lost a bit of direction the previous year, resulting in some confusion and frustration on the part of adjudicator candidates. One of the first things I did when taking over as Music Board Chair in 2016 was to appoint Tom Foley to head the Adjudicator Committee.

Tom's leadership has paid off, as he and others on the Committee have sorted out the logjams and we now have four new judges, with several more currently going through the qualification and shadowing process.

This year we intend to continue to improve and better document the qualification process so that it is clear and fully meets our needs. In addition, we will be exploring ways to ensure that piobaireachd adjudication is delivered with high quality and consistency.

In general (and this goes for all categories of adjudication), we have not had a regular ongoing professional development or "continuing education" program for judges. A priority for 2017 will be to re-invigorate this effort and bring us in line with what other Associations are doing in North America.

Grading

Everyone's favorite topic, right? In early 2016 we put a lot of thought and effort into how to improve the grading process.

The results were that we had a tremendous reduction in the number of grading appeals compared with the previous year. Yes, there were a handful of individuals who were not happy with not being upgraded (and a few who were not happy when they were upgraded!), but all in all I firmly believe the process is working well.

First let me say that the job that BJ Gunn, Chair of the Grading Committee, and his wife Erin (and others) have done to collect and enter contest data over the past several years is in my opinion the biggest effort that any WUSPBA volunteer undertakes, hands down. Scoresheet data and summary sheet information from every contest is captured. This amounts to well over 4,000 solo and band scoresheets from around 450 contest events each year.

This is done to ensure that the CPL – the Competitor Performance Level – that the judges complete after each performance is utilized in a meaningful way, as well as capturing recommendations from judges regarding whether the competitor should be moved up or down a grade. In addition, the aggregate rankings, the number of times a competitor places, and the highest prize they received in their grade is also examined.

But that is where the "numbers-related" part of the process gives way to perhaps

more subjective but equally important nonquantitative input.

The Grading Committee as well as the entire Music Board engages in a discussion on each potential re-grade that can include personal knowledge (e.g., having heard and/or judged the individual or band), video recordings, input from teachers, applications for regrading and other circumstances or information that could have a bearing on an individual's or a band's grade.

What I witnessed as part of the Grading Committee deliberations – the depth of conversation and the thoughtful consideration given to each case – was gratifying and reinforced my high opinion of everyone involved.

I have no doubt that the grading process will continue to improve and get smoother each year. Again, I hope everyone understands and appreciates the many hours of hard work that go into make it successful.

Professional Development

Beyond the need for continuing education for adjudicators, at the WUSPBA AGM we formed a Music Board subcommittee to explore ways to share the incredible expertise we have in the Association and elsewhere, through on-line videos, workshops, "TED" talks (brief presentations on a single subject), etc. This is still in the beginning stages, but stay tuned, we will start this up in 2017 as well.

Thanks for your support and your willingness to have dialogues on these and

related topics. I wish everyone a successful year, and I'll see you "on the boards!"

Two Named to the WUSPBA Circle of Honor

This year, members of the Presidents' Council nominated, and the Executive Committee approved, two highly esteemed pipers to the WUSPBA Circle of Honor: Jimmy McColl and

Charles Lumsden. Brief descriptions of their accomplishments and contributions to the Association are below and also on the website.

Charles "Charlie" Lumsden

Charles Lumsden was born in Broxburn, Scotland, and immigrated to California with his mother, Margaret, and his father, Bill. As a young boy, Charles was taught to play the pipes by his farther, who himself was an important influence in the pipe band community of Southern California.

Although the bagpipes were his favorite instrument, Charles also picked up drumming and Highland dancing, and competed successfully in all three areas in his younger days.

One of the highlights of his young piping career was returning to Scotland and winning a silver medal at Cowal in the Boys' Division, and playing with the Pumpherston Pipe Band.



During the mid-70s and -80s, Charles had a thriving solo piping career and was the Pipe Major of the Caledonian Pipe Band of Southern California.
He became the Pipe Major when

he was in his late teens and was able to attract some of the most talented players in the area, which made the Caledonian a successful competitive Grade 2 band.

After a break from pipe bands to pursue other musical endeavors, which included playing guitar and singing with the folk group "The Irish Beggarmen," Charles returned to the pipe band scene and joined the Beach Cities Pipe Band, which later became the Los Angeles Scots. Charles was the Pipe Sergeant of the Los Angeles Scots from 1991 to 1995 when they tied for first at the World Pipe Band Championships in Grade 2.

Charles then transitioned from the Los Angeles Scots to play with the Los Angeles Police Pipe Band. In 1999 Charles and his son Kyle joined the Alameda County Sheriffs Pipe Band, which placed second overall in Grade 2 at the Worlds with a first place in piping.

Other bands that Charles played in alongside Kyle were the Caber Feidh, Los

Angeles Police, Misty Island, NAPB and finally returning to the Los Angeles Scots. It was a great pleasure for Charles to play in the Grade 1 circle at Glasgow Green with his son.

Charles was an adjudicator for the WUSPA for many years, and it is noteworthy that he was an ensemble judge due to his talents and knowledge in both piping and drumming. In his years of judging, he was fortunate to travel to different games across the country and took pride in being both a fair and honest judge.

For Charles it really was always about the music that came so naturally to him -- the music that led him to lifelong friendships through the years, not only in the pipe band world, but in all of his musical careers.

Charles always joked with his wife, Janet, daughter Brianna and son Kyle that out of all of his musical endeavors he was pleased to be recognized as a legend in his own mind -- but really he is a legend to them.

James "Jimmy" McColl

James McColl, better known as Jimmy McColl, was born (1928) and raised in a small town in Scotland called Shotts. In Shotts at the time Jimmy was a youngster, a world-class pipe band existed and functioned as such. Jimmy, taking a great liking to the way they sounded, joined the band and learned to play the pipes from Tam MacAllister, Sr., the leader and Pipe Major of the Shotts and Dykehead Pipe Band, which to this day is still a world-class pipe band. It won the World Championship

various times from 1948 forward, most recently winning in 2015.

Later in his career, Jimmy took an interest in solo piping, and between 1949 and 1955, he won most of the major awards, including the Aggregate at Cowal four consecutive years from 1949 forward. This feat had not been accomplished since Willie Lawrie did the same prior to World War I. Jimmy also won the coveted Highland Society of London's Gold Medal at the Argyllshire Gathering at Oban in 1953, playing "The King's Taxes."

between 1955 and 1975, and it is possible that he is the only piper at present who can play the Ancient Martial Music in the style that it was played before the Battle of Culloden in 1746.

Jimmy has instructed many schools of piping and workshops through his career, including the Balmoral Summer Schools. He still enjoys judging and entertains many of his now-grown students with lively conversation of the ancient art of bagpipes.

At the present time, Jimmy is enjoying retirement in Laguna Woods, California.

Although retired he still keeps the wind going through his pipes.

An Original Piobaireachd: The Broken Mace

So it's the evening of December 1st, 2016, and members of the Kern County Pipe Band are gathered to participate in the 34th annual Bakersfield Christmas Parade. So we're all tuned up and waiting, and waiting, because the parade never starts on time and we are number 84 of 129 entries.

Waiting initiates boredom, boredom initiates other activities. So one of the pipers from Highland High School approached the Drum Major and asks to see his mace.

The Drum Major hands the kid his mace.

The kid starts twirling the mace, and everything looks like it is going well for a short period of time, but then CRASH!!! TINK!!! THUD!!! There lies the mace with the head broken off and the shaft with a broken chain.

Needless to say, the Drum Major was NOT HAPPY. Neither was the young piper.

The Drum Major led using the parade with the broken shaft of his broken mace. Fortunately, the young piper marched and played without his bass drum being broken.



Moral of the story: Drum Majors, DO NOT let pipers borrow your mace. Pipers, DO NOT ask Drum Majors for their mace.

The incident prompted

me to write this piobaireachd, which if you look at it carefully, is an IRREGULAR TUNE. There are 6 bars in the first line of the tune; 8 bars in the second line of the tune; and 4 bars in the third line of the tune.

An irregular tune for an irregular incident by an irregular composer: the complete tune is on page 23.

Note: The Kern County Pipe Band had 10 pipers, 4 snares, 2 tenors and a bass that evening. The band is comprised of members of the Highland high School Pipe Band and other pipers and drummers from Bakersfield, Taft and Tehachapi. It is a Grade V band and will be competing in 20117 at several WUSPBA-sponsored contests. The Pipe Major is John Eric Partanen. The Pipe Sergeant is Travis Combs. The Drum Sergeant is Peter MacQueen.

Meet the Phoenix Pipe Band

Pipe Bands don't go back very far in the Great State of Arizona. The first bands traveling through were from Canada, hired to come down, enjoy some heat, play for Burn's Night and then travel home.

Originally the Phoenix Scottish Pipe Band

It wasn't until 1958 that there was finally a permanent pipe band in the state, launched when 13 Arizona transplants got together and formed the Phoenix Scottish Pipe Band.

In its early years, the band was under the direction of P/M Glen Moore and D/S Chuck Martin. The first D/M was Jock MacIntosh, a flamboyant front-man, known for dropping the mace and at one point throwing it into the crowd. The story is that he was directing the band to a right turn when the mace flew out of his hand and into an unsuspecting parade audience. Founding band members included the brothers Joe and Bill Leonard, Cornell Ross, Ian MacRae, Sam MacKay, and Chuck Martin's son Graham.

Like so many bands getting started, the band's uniform was basic: MacKenzie tartan kilts, hair sporrans, hose tops and spats, glengarries and khaki shirts. Two years later, D/M MacIntosh worked a deal with the local Pepsi bottler: new uniforms,

(Modern MacGregor kilts, white shirts, etc.), Clansmen drums and place to practice in exchange for wearing a Pepsi patch on our right sleeve and stickers on the drums. A pretty good deal, except I can't tell you how many times the band was introduced as the "Pepsi Pipers."

2016 - Moved to Grade III, Added Grade IV

Over the years the band's size has varied, from the original 13 to 50-plus members and everything in between. Fifty-nine years later, we can look back on a myriad of uniform and personnel changes along with changes in direction, from parade band to competition, back to parade and finally a competition band once more.

At the 2016 WUSPBA AGM, the band was moved up from Grade IV to III, and in May the band added a Grade V corps to the roster.

Those early years as a parade band demonstrated that Billy Crystal was right.

To paraphrase his Saturday Night Live character, "It is better to look good than to

play good." Grace note and movements were optional.

But then, in 1964, our wonderful winter weather played to the band's benefit. Jock Snedden, founder of the Sierra Highlander's PB made the decision to spend a few months in Phoenix. Once he started teaching the band, grace notes were no longer an option, and in two years he had the band ready to compete at the old Santa Monica games.

Our first time out, in Grade C, we proudly returned to Phoenix with First Prize, The Ye Old Mucky Duck trophy. The P/M was Stan (Tim) Smith and D/S Bob Matlack. The band had just the minimum required: with six pipes, Tim Smith, Ian MacRae, Bob McCann, Ernie Nelson, Chris Hossack and Len Wood; three snares, Bob Matlack, Duncan Hossack, and Danny Strof and our bass, Jim Grant.

In another bit of good luck at that contest, we met Calvin Biggar, then General Secretary of the PCPBA, who would become our longtime friend and supporter.

2008 - The Phoenix Pipe Band

In 2008, our 50th year, the band simplified the name from Phoenix Scottish Pipe Band

to Phoenix Pipe Band. The band's support was coming from both the Scottish and Irish communities, and the change seemed appropriate.

The band still wears the Modern MacGregor tartan (PPB set), but ties and waistcoats have replaced the hose tops, spats and hair sporrans.

A Three-Year Plan

2016 was a good year for the band with strong wins in Phoenix, Las Vegas, Costa Mesa and Flagstaff. As with all pipe bands, the year didn't just happen. We had developed a three-year plan to grow the band, develop good players, upgrade the music and make management changes when required.

We are fortunate enough to have some very good players who live outside Central Arizona, and for them we hold monthly practices on a Sunday in Prescott. This alone has had a very positive impact on the band's performance.

Fun as Well as Work



It is not just work, however. The band has a great time as a bunch of friends who happen to play nice bagpipes and drums. We don't miss too many opportunities to get together for a cookout

or to celebrate wins and losses after the contests. It is always dinner together at the end of the day.

Report on the Alliance of North American Pipe Band Associations' Meeting:

Competition Requirements, Band Grading, Inappropriate Behavior, African Blackwood and More

I am writing this article just after returning from my meetings with ANAPBA at Winter Storm. I want to first congratulate all of the many individuals who represented themselves and WUSPBA at the contest. I was so proud of their abilities and how well they performed on such a large international stage. I would like to thank each person for the countless hours of practice you put in, which was evident in the outstanding level and ability I saw this weekend at Winter Storm.

Thanks to Winter Storm

I would like to also thank Winter Storm for supporting and helping the ANAPBA organization this weekend. If you haven't ever been to Winter Storm it is something I think all pipers and drummers should put on their bucket list.

Many Issues Discussed

Let me tell you some of the many issues that were discussed at the meetings this weekend. I hope you all know that ANAPBA represents all of the North American Pipe Band Associations and we all work together to create common ground.

Many of the associations have issues that relate to their particular area and demographics, but whenever possible, we try and make competition requirements the same across the board. This allows bands and soloists from anywhere in North America to compete in any association and find that the solo and band requirements are the same.

Competition Requirements for Grades IV and V Bands

We spent time this weekend working on the competition requirements for Grade V and IV bands. In Grade V, it was recommended that the March Medley be eight parts of simple time marches. This would remove the time requirement and limit it to how many bars of music is played. This is slightly different than our requirement, and we will bring this up for a vote at the next AGM.

For WUSPBA the biggest change would be the recommendation for the Mini MSR in grade IV. The recommendation for the Mini MSR is to play four parts of 2/4 march, four parts of strathspey and four parts of reel. These tunes could be two-parted tunes or four-parted tunes. This recommendation will not affect our bands at this time.

Many judges feel that with only two parts of strathspey and two parts of reel isn't long enough for them to hear and make a good assessment of how the bands are play these types of tunes.

For the timed medley in grade IV, judges feel the wording and requirements should be timed with four different categories of tunes being played. This means that a band needs to play four types of tunes (i.e., reels, strathspeys, different times signature of marches, hornpipes, jigs, etc.), but still within the allotted time.

All of these issues will be brought up at the next AGM and will have no effect on WUSPBA during this coming season.

Visas for Canadian Judges, Teachers

We talked about how to get P3 visas for Canadians who WUSPBA bands bring down to judge and give seminars.

The EC will be looking for how to put this into effect for the 2018 season. This may require all of us to work together and plan ahead so we can fill out one form and do it all at once. We will be getting more information out as it becomes available.

Inappropriate Behavior

Many of the pipe band associations have had problems with their members being involved in inappropriate behavior. These issues include bullying at games and on the internet of judges, game sponsors and associated members. As a result, each association has been asked to come up with a Member Protection Policy.

The WUSPBA will be looking into this and trying to have a policy ready by the next AGM for discussion and voting. Policies will have a clause that says we will uphold actions taken against an organization or individual by another pipe band association.

We are finding that individuals who are conducting inappropriate behavior and having sanctions put on them are trying to join another association to avoid the penalties for their behavior.

African Blackwood: Endangered

You may be aware that African Blackwood has been added to the list of endangered species under the Convention on International Trade in Endangered Species (Cities), subject to

restrictions similar to restrictions on ivory. This brings up concerns if someone is taking their pipes outside the country.

We, along with ANAPBA, are looking into how this will be regulated in our different countries. I don't think there will be an issue, but we should be vigilante and try and find out all we can. As soon as we get some answers, I will let you all know what we find out.

I would like to talk with you all about ways to answer most of your questions regarding WUSPBA. I want you all to know how impressed I am with our many branch presidents. You should direct most of your questions to these presidents; I feel you will be pleased with them and how they handle your questions.

Original Piobaireachd Music Competition

This competition calls for copies of original piobaireachds to be submitted by composers to a panel of qualified judges. The piobaireachd submissions must be original to the composer(s), of any style, and cannot have been published before. Prize awards for the top three compositions will be £500/£250/£100. Submissions must be received by April 1, 2017, and winners will be announced in May 2017.

Piobaireachd Competition Rules

- 1. Composers must have reached the age of 21 by the final submission date.
- 2. Piobaireachd submissions must be original to the composer(s), and not been published before.
- 3. Submissions may be of any form (Lament, Salute, etc.) preferred by the composer(s).
- 4. Only one submission is allowed from each composer.
- 5. Submissions of the music score must be unmarked PDF files, attached to an introductory email with the composer's contact information. No indication of the composer's identity or composition name on the score or file is allowed. Name the PDF file: "SPS contest".
- 6. Submissions must be generated by computer in a recognizable arrangement format (PS, Binneas, McIntosh). Handwritten scores or written notations on the score are not accepted.
- 7. Submissions must also include an audio electronic file (MP3) of the composition played on pipes or practice chanter, with no voice or identifying markers. Name the MP3 file: "SPS contest". If the file size is too large, it may need to be split in to two files. Name the files according to: "SPS contest 1" etc.
- 8. Complete submissions must be submitted by April 1, 2017 to the email address: shastapipingsociety@gmail.com
- Composers will retain all copyright, but must agree to grant the sponsors free right to publish the score in a music collection and use recordings of the arrangement to advertise future competitions.
- 10. Composers must have the ability to receive monetary awards from the sponsors by PayPal account.
- 11. All decisions made by the representatives of the sponsors are final.

Judging

Piobaireachd submissions will be catalogued, provided individual identification, and sent under blind cover to the panel of judges. Results of the competition will be announced to each of the composers during May, 2017, and announced to the public shortly thereafter. Awards will be distributed within 30 days of the winner's announcement by PayPal payment.

Shasta Piping Society
